



Training Application Manitoba Environmental Certification & Regulation Awareness

On July 1, 1992 the Manitoba Government implemented the Ozone Depleting Substances Act & Regulation. The legislation requires that any person working on (i.e. purchasing to work on, servicing, recharging, repairing) refrigeration or air conditioning equipment that contains a regulated substance be certified. There are also several other responsibilities that are associated with certification. On September 10, 2009 MOPIA adopted a new and updated training manual "*Environmental Awareness Training for Ozone Depleting Substances (ODS) and Other Halocarbons*"

Please note that when there are enough approved applicants (Approx. 15-25) a course date (location, etc.) will be set. **Apply below for the MOPIA one day certification course.** You will be notified regarding your application for certification training approximately 5-10 days prior to the date of the next offered course.

The cost of the course is \$100.00 plus \$25.00 annual certification valid to May 31 of the current year and \$50 for the training manual OR \$40 for the CD version (plus applicable PST charges). **The total amount \$178.50 (training manual) OR \$167.80 (CD version) can be paid by cheque or cash the day of the course.**

Please note that this is not trades training, it is regulation and environmental awareness training for certification under MR 103/94.
