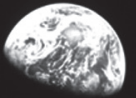

Both the Manitoba Ozone Depleting Substances and Other Halocarbons Regulation and the Federal Code of Practice mandate the use of identifying labels on regulated products and equipment.

MOPIA offers these labels to our stakeholders and these are available for purchase from our Winnipeg location.

WARNING:



Contains (CFC's/HCFC's/HFC's/Halons) a substance which harms public health and the environment by destroying ozone in the upper atmosphere. Must not be vented to the atmosphere. Must only be serviced by a trained service technician as defined by the Manitoba ODS Regulation.

WARNING LABELS

Warning Labels should be placed on all regulated products (equipment) that contain or are intended to contain a regulated refrigerant.


Nearly all new equipment after 2012 likely already have this type of label, but older units do not.

REFRIGERANT RECOVERED DECLARATION LABELS

Refrigerant Recovered Declaration labels are required on systems, equipment, cylinders, (i.e. cars, fridges, freezers, empty cylinders, etc.) that have had their refrigerant recovered.

They may be stored or may be intended for resale, reuse, scrapping or recycling.

ODS UNIT I.D. LABELS

ODS-Unit ID labels are to be applied to all units that do not have a label indicating the type of gas contained and related information such as quantity and the date serviced. All systems should already have this type of label affixed from the factory. However, for those that do not and any older (prior to 1993) system that you may be working on, make sure to affix this label. Also if you have retrofitted a unit with another (different) type of refrigerant, you must affix this label. (Ref. Section 25 of Regulation)
