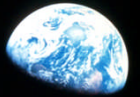

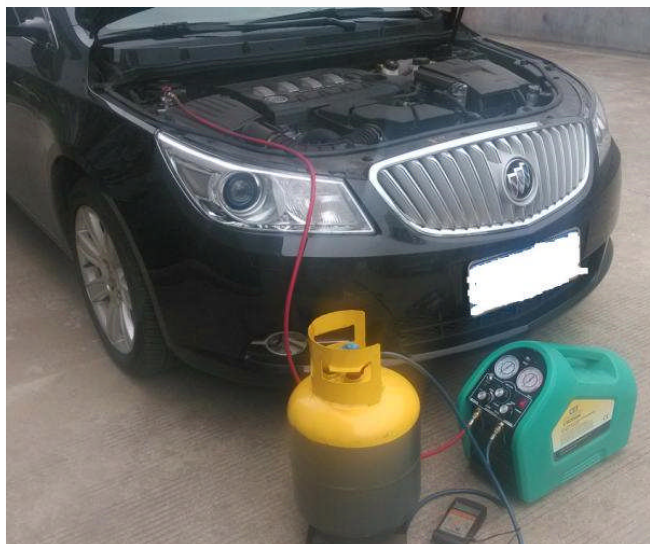

## Manitoba Public Insurance Auto Refrigerant Recovery Initiative



Manitoba Public Insurance (MPI) has been a leader in the recovery and stewardship of refrigerant from vehicles since 1995. While Manitoba is in a unique position as the vehicle insurance agency (aka MPI) is actually a crown corporation of the provincial government, it took the responsibility of refrigerant recovery seriously as legislation mandated the recovery of refrigerant from vehicles being destined to recycling or a similar fate. The Manitoba Ozone Depleting Substances and Other Halocarbons Regulation broadly requires everyone who intends to scrap a unit (i.e. car, fridge, air conditioner, water cooler, dehumidifier) to recover the refrigerant.

To date, upwards of an estimated 500,000 vehicles have been processed with the refrigerant safely recovered. The climate change or global warming potential (GWP) benefit of this initiative alone is enormous. The actual ozone protection and GWP benefit depends on the type and quantity of refrigerants processed.

MPI, (through the expertise of various contractors), process hundreds of car A/C at their vehicle compound in Winnipeg each week and in Manitoba locations including Brandon and Dauphin. The most difficult vehicles to include and process tend to be those in remote northern communities and select winter road accessible only First Nations. However, focus and solutions are being explored for these regions too.

## Federal HFC Controls Take Effect – April 16!

Environment and Climate Change Canada have been at the forefront internationally to control HFCs with the encouragement of MOPIA and other stakeholders. The passing of the Kigali Amendment as part of the Montreal Protocol was a landmark step in controlling HFCs for the first time internationally. Now, Canada is taking actions to phase-down their use including importing restrictions in various applications. On April 16, 2018 – this week, an Amendment came into effect that has far reaching effects. For example, autos must not be imported into Canada (beginning with the 2021 model year) with HFCs and the importing of pressurized containers of under 2 kg of a HFC are banned.
