## **Loblaws Awarded \$12 Million for Refrigeration System Conversion**


Refrigerants used today in most air conditioning and refrigeration systems are among the most potent greenhouse gases on the planet, contributing substantially to climate change. These include the range of refrigerants known as CFCs, HCFCs and HFCs. While international efforts including the Montreal Protocol and its' amendments (Kigali) have substantially reduced the impact of these harmful gases, they will continue to be in systems for years to come. As such, government and industry must strive to initiate efforts to retrofit to greener technologies.

The Federal Government under a variety of climate action funds may have funds available upon completing an application process and meeting their criteria under various climate change incentives/ initiatives.

### Canada's Changing Climate Report Released



On April 2, 2019, The Government of Canada released its *Canada's Changing Climate* Report. Highlights include:

- Canada's climate has warmed and will warm further in the future, driven by human influence.
- Both past and future warming in Canada is, on average, about double the magnitude of global warming.
- Oceans surrounding Canada have warmed, become more acidic, and less oxygenated, consistent with observed global ocean changes over the past century.
- The effects of widespread warming are evident in many parts of Canada and are projected to intensify in the future.
- Precipitation is projected to increase for most of Canada, on average, although summer rainfall may decrease in some areas.
- The seasonal availability of freshwater is changing with an increased risk of water supply shortages in summer.
- A warmer climate will intensify some weather extremes in the future.
- Canadian areas of the Arctic and Atlantic oceans have experienced longer and more widespread seaice-free conditions.
- Coastal flooding is expected to increase in many areas of Canada because of local sea level rise.
- The rate and magnitude of climate change under high versus low emission scenarios project two very different futures for Canada.

In 2018, damage caused by climate or severe weather events reached \$2 billion.

#### **Enforcement of the Regulation**



Any person attempting and/or caught with purchasing regulated а substance (i.e. refrigerant) or anything attached to the closed refrigerant loop from wholesaler, via Kijiji, privately, a scrap yard or auction without having a valid certification is liable for penalties under Manitoba ODS Act of up to \$50,000 and/or 6 months imprisonment on a first offence.

Always make sure you have your valid certification card on-hand when making this type of purchase/transaction. The seller <u>MUST</u> see your card to authorize the transaction or they are liable for penalties up to \$500,000 on a first offense for selling products unlawfully. Yes, that means all wholesalers, retailers or any others selling regulated products have the responsibility to see and verify validity and record your certification # from your card.

MOPIA has issued a new "Regulated Products" Bulletin (seen above) highlighting what regulated products actually include and you may see it on our website.

### May 11 – Next One-day Certification Class in Wpg

MOPIA will be hosting our next one-day certification class in Winnipeg on Saturday, May 11 at Red River College. Any person working on the gas side of an air conditioning, and/or HVAC/R system requires this provincial certification under Manitoba Regulation 103/94.

Persons who require this certification should register in advance by contacting MOPIA by email (mopia@mymts.net) or phone (see above). The cost of participating is \$185 per student.

The one-day class typically runs from 8 am – 6 pm with the exam. For those unable to attend an onsite/in-class setting, living in remote rural communities or other circumstances, you may be eligible to do the class via correspondence. MOPIA also hopes to offer future classes in Brandon, The Pas, Dauphin and Winkler if there is interest.
