

New White Goods Bulletin Released



MOPIA just released a new white goods management Bulletin. The information brochure is aimed providing guidance to the general public and our stakeholders on what options may be available for the disposal of white goods. White goods include everything from water coolers, fridges, freezers to dehumidifiers.

Thousands of white goods are disposed of each year across Manitoba. It is crucial that each one of these is decommissioned safely including having the refrigerant recovered and some contain mercury switches, oils and all have recyclable elements such as plastic, glass or metals.

Next Certification Class Dates for Winnipeg and Brandon



MOPIA will be offering our next one-day certification class in Winnipeg on Saturday, June 17 and in Brandon, Wednesday, June 28. Please contact MOPIA to register.

Anyone working on A/C or HVACR systems handling regulated products and refrigerants must have this certification or they risk penalties of up to \$50,000 and/or imprisonment not exceeding six months on a first offence.

2017-2018 Certification Renewals Ensure you Renewed!!



Another year is upon us for those in the air conditioning and refrigeration sectors. June 1 was the expiry date for all certificate holders in Manitoba.

If you are a business owner, ensure that each of your air conditioning (HVACR) techs have renewed their certification. Penalties for non-compliance are significant and range from up to \$50,000 or 6 months imprisonment (or both) on a first offence and even greater for companies in non-compliance, up to \$500,000 on a first offence.

It's simple to renew your certification. The annual fee is \$25 and can be paid in nearly any manner. Via credit card, PayPal (website), calling in with a credit card or via sending in a cheque or by debit or cash in person at MOPIAs offices.

Did you know: MOPIA does not receive any government funds or grants for operations and the certification fee is dedicated to pay for all aspects of our services from info bulletins to salaries, office space to outreach initiatives.
