

Tribute to D. Brian Baker



D. Brian Baker (57) (seen above at left), a Winnipeg business owner, active and involved volunteer and participant in the HVAC/R sector, passed away from an aggressive cancer this past January. From being on the original government facilitated working group on ozone depleting substances back in 1992, to Chair of HRAI Canada and a Chair of RSES and an international rep., to being on the provincial trade advisory council, it would be hard to find anyone more engaged with the industry. Brian was also a long-time MOPIA trainer and independent instructor in the power engineering sector. Brian was a one-time MOPIA Board member and could be seen encouraging best practices and raising the bar from all he encountered. A memorial service has taken place. Brian leaves behind his wife Denise and three grown children and their families.

MOPIA's next one-day environmental and regulation awareness certification class will be held on Wednesday, March 29 at the Canad Inn (McPhillips) in Winnipeg.

If you know of anyone requiring the certification, please let them know. The class runs from 8 am – 5 pm and includes an examination. Anyone working on A/C or HVACR systems handling regulated products and refrigerants must have this certification or they risk penalties of up to \$50,000 and/or imprisonment not exceeding six months on a first offence.

March 7 was when the final installation of the instrumentation of SAGE III took place on the International Space Station (ISS). Within 90 days, the activation and calibration of SAGE III will happen.

The instruments are designed to measure ozone molecules and other key aerosols in the atmosphere that will assist in mapping chemicals in the stratosphere. The launch is called CRS-10 (SAGE III).
