MOPIA meets with Conservation and Climate Minister Guillemard

MOPIA met with Manitoba's Minister of Conservation and Climate, The Honourable Sarah Guillemard, at the Manitoba Legislature on March 2nd. The meeting was an opportunity to highlight MOPIA's past achievements, update the Minister of MOPIA's current initiatives and the many positive climate mitigation opportunities going forward. The Minister shared ideas and was encouraging.

MOPIA reflected on our success in showcasing Manitoba's climate and ozone strategies to the world, having hosted several international study tours in collaboration with the United Nations Environment Programme with guests from Burkino Faso, China, Bahrain, Uruguay and other nations.

MOPIA highlighted how we have facilitated certification training, now reaching over 16,000 persons including for the first time, some on First Nation communities. Potent greenhouse gases are being captured from fridges to autos and all types of equipment containing refrigerants harmful to the environment. How MOPIA is self-sufficient and not dependent on government subsidies, among other qualities

Going forward, MOPIA is encouraging a regulatory update, including amendments to streamline and improve the existing Regulation. MOPIA continues to gauge and inform our stakeholders of the international agenda to phase-out certain refrigerants (i.e. HFCs) and encourage sustainable, climate efficient HVAC/R technologies.

MOPIA will continue to dialogue with the Ministers' staff to ensure everything from environmental enforcement to strategies on how MOPIA will contribute to make Manitoba a leader in green and climate approaches.

Certification Training Dates



MOPIA's next one-day provincial certification class is Saturday, March 28th in Winnipeg. Any person working on the gas side of an air conditioning, and/or HVAC/R system requires this certification under Manitoba's ODS and Other Halocarbons Regulation 103/94.

You must register in advance by contacting MOPIA at email (mopia@mymts.net) or phone (204.338.2222 or 1.888.667.4203). The cost of participating is \$185 per student.

The class will run from 8 am – 5 pm with an exam. For those unable to attend an onsite/in-class setting, living in remote rural communities or other circumstances, you may be eligible to do the class via correspondence.
