


Sea Ice in Arctic Reaches Limit

Information compiled by the National Snow Ice and Data Centre and NASA determined the Arctic Ice Region reached its minimal extent on September 17 for 2014. This is the 6th lowest since satellites began measuring the region. 2012 holding the record depletion.
