
### **Manitoba Heat Pump Initiative**

#### 2025-26 Certifications Issued





If you are a technician working on the gas side of an air conditioning or refrigeration system, you should have received your new 2025-26 certification card. You must have one to purchase and work with all new or used associated regulated parts and equipment. If you don't, you can still renew, take training or you risk penalties of up to \$50,000 and/or 6 months imprisonment. The penalties are very high.

Environment Officers with both Manitoba Environment and Climate Change, as well as, Environment and Climate Change Canada enforce non-compliance issues. They accept and follow up on tips and consumer concerns related to techs or companys not complying with the Regulation/Act.
